Report of Scrutinizer

I, P. V. Subramanian, Company Secretary in Whole-time Practice, (Membership No. ACS-4585 & CoP No.2077) having my office at "Sampriti", 3rd Floor, 81/8, Regent Estate, Kolkata-700092, have been appointed by the Board of Directors of Nicco Parks & Resorts Limited ("the Company") as the Scrutinizer to conduct the Postal ballot process through electronic voting ("remote e-voting") instead of submitting the Postal Ballot Form physically in respect of the following 2 (two) Ordinary Resolutions:

- "Re-appointment and terms of remuneration of Mr. Abhijit Dutta (DIN: 00233374)
 as Managing Director of the Company and designated as Managing Director and
 Chief Executive Officer of the Company for a period of 1 (one) year with effect
 from January 1, 2022 to December 31, 2022"; and
- "Appointment of Mr. Ritendra Narayan Basu Roy Choudhury, IAS (DIN: 05119676), Nominee of West Bengal Tourism Development Corporation Limited, as a Nominee Director of the Company, liable to retire by rotation.",

pursuant to the Postal Ballot Notice dated 11.02.2022 issued under Section 108 and Section 110 of the Companies Act, 2013 read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014 ("the Rules"), as amended, read with the General Circular Nos.14/2020 dated April 8, 2020, 17/2020 dated April 13, 2020, 22/2020 dated June 15 2020, 33/2020 dated September 28, 2020, 39/2020 dated December 31, 2020, 10/2021 dated June 23, 2021 and 20/2021 dated December 08, 2021 issued by the Ministry of Corporate Affairs ("MCA") (hereinafter collectively referred to as "MCA Circulars") and pursuant to other applicable laws and regulations.

The Postal Ballot Notice dated 11.02.2022 along with statement setting out material facts under Section 102 of the Act in respect of the abovementioned resolutions, as confirmed by the Company, was sent, via e-mail only to the Members whose names appeared in the Register of Members / List of Beneficial Owners as received from Depositories and whose e-mail addresses were registered with the Company / Depositories.

The Company had availed the e-voting facility offered by National Securities Depository Limited ("NSDL") for conducting remote e-voting by the shareholders of the Company.



The shareholders of the Company holding shares as on the "cut-off" date of Friday, February 18, 2022 were entitled to vote on the resolutions as mentioned in the Notice.

The voting period for remote e-voting commenced on Friday, February 25, 2022 at 9:00 a.m. (IST) and ended on Saturday, March 26, 2022 at 5:00 p.m. (IST) and the NSDL e-voting module was disabled thereafter.

The votes cast under remote e-voting facility were thereafter unblocked in the presence of two persons who acted as witnesses as prescribed under sub-rule 4(xii) of Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended.

I have scrutinized and reviewed the votes cast through remote e-voting based on the data downloaded from the NSDL e-voting system

The Management of the Company is responsible to ensure compliance with the requirements of the Companies Act, 2013, Rules and the MCA Circulars relating to remote e-voting on the Resolutions contained in the notice of Postal Ballot.

My responsibility as scrutinizer for the voting on postal ballot through remote e-voting is restricted to making a Scrutinizer's Report of the votes cast in favour or against the said resolutions.
